## LICENSE AGREEMENT AND POLICIES FOR PRIVATELY OWNED CARTS

Members of the Artesia Country Club are allowed to own golf carts and operate such cars on the golf course under the following terms and conditions:

- 1. The total number of privately owned golf carts operating on the golf course shall be at the sole discretion of the Board of Directors, based on recommendations provided by the Course Superintendent and Course Manager or Golf Pro.
- 2. All privately owned carts must be approved by the manager of the Pro Shop, be of standard commercial design and adhere in appearance to standard golf etiquette.
- 3. All cart owners must carry liability insurance including coverage for bodily injury and property damage. The cart owner must furnish the Artesia Country Club a Certificate of Insurance. This Certificate of Insurance must be renewed annually.
- 4. The owner of the cart licensed hereunder hereby indemnifies and agrees to hold harmless the Artesia Country Club from any and all claims arising out of the use or operation of privately owned golf carts on the Artesia Country Club premises.
- 5. Applications for license to operate a privately owned golf cart on the golf course will be accompanied with an annual payment of \$690 (plus sales tax). This fee will be for a single Golf Cart fee only. Any additional private carts by the same family will be charged an additional \$100 (plus sales tax) per cart. No refund will be made if the owner sells or otherwise decides he or she does not want this privilege during the year's period. The due date for the License Agreement year will be January 1 through December 31. Agreements entered into after January 1 will pay a pro rata amount from the first day of the agreement month through December 31.
- 6. An owner of a privately owned Golf cart, including the members of the owner's family covered by his or memberships, may use the cart and include riders at no additional charge. A privately owned cart may not be used by persons other than the owners.
- 7. Operation of privately owned carts must obey all rules set forth for operators of Club rental carts.
- 8. Operators of privately owned carts must register in the Pro Shop prior to starting play. They must, at this time, register the names of all riders in the cart.
- 9. All cart operators must have a valid driver's license.
- 10. All maintenance and repair of privately owned golf carts will be the responsibility of the cart owner. Should the Country Club or the Club Professional become involved in the maintenance or repair of a privately owned golf cart the cart owner will be billed for this service at the prevailing commercial rate.

## LICENSE AGREEMENT AND POLICIES FOR PRIVATELY OWNED CARTS

- 11. All privately owned golf carts will display a decal, provided by the club, indicating the member and private cart owner is in good standing with the club. Placement of the Country Club decal will be placed in the specified place dictated by the club to allow ease of inspection by Country Club Directors, Golf Pro and Course Superintendent. The decal will be renewed annually upon receipt of payment and proof in insurance. Please see attached sheet for decal location placement.
- 12. Failure of a private cart owner or member of his or her family to abide by the terms and conditions of the License Agreement will be cause for the Artesia Country Club Board of Directors to immediately void the Agreement without refund of unused cart license fees.
- 13. The Board of Directors reserves the right to revise this agreement at any time deemed necessary.
